[Archive]: Letters and Documents from the North Carolina Estate of Colonel Andrew C. Cowles, Confederate Officer and Politician, circa 1830 – 1880

A small family archive consisting of over 50 personal family letters and over 125 estate documents and letters of Andrew C. Cowles, a prominent Confederate Colonel and politician from Hamptonville, North Carolina. During the Civil War Andrew Cowles served as a member of the North Carolina House of Representatives (1860-64), and he commanded the 18th Brigade of the 75th Regiment of North Carolina Militia at Hamptonville. Immediately after the war he served as State Senator, from 1865-66, and again from 1870-74. He also ran a successful whiskey distillery.

Most of the letters and documents span the years from the late 1860s through mid-1880s, including many dating back to the early 1830s, and a few up to about 1900. Half of the personal family letters were written by Cowles' wife Maggie Reynolds while he was away on senate business in Raleigh: most are long letters, typically 4 to 6 neat and densely written pages in her small legible hand, and containing much intimate personal content and related domestic news and happenings at the estate in Hamptonville. Also included are letters from Andrew Cowles to Maggie, and letters from various siblings and relatives from both the Cowles' and Reynolds' extended families. These contain both personal content and much additional content about the running of the Hamptonville estate and other properties in North Carolina and other states. Most of the letters have been retained folded in their original envelopes (with stamps).

Among the estate documents are many letters by and to members of both the Reynolds' and Cowles' family, and friends and associates in their circle. Included are over 125 miscellaneous documents and letters: ranging from receipts to formal letters, and including all manner of estate documents: summons, insurance policies, ledger accounts, etc., dating from 1830-1880.

Most of the letters and documents have been retained folded, overall very good, with scattered short tears and fraying to the edges and folds of some items. A list of selected items follows:

I am looking forward with bright anticipation to the 26 th [the wedding] as the time when I shall be happy indeed ... preparations ... I hope to make many of my

friends happy on that night. I wish you would come down on the Saturday before ... / We intend to invite Miles & Andrew Cowles ... / I saw Pink in Philadelphia ... Write me whether you will be down on Saturday or not. / Your affectionate Friend Absey"
